

## **GROUP LONG TERM DISABILITY INSURANCE**

Group Long Term Disability insurance from Standard Insurance Company helps provide financial protection for insured members by promising to pay a monthly benefit in the event of a covered disability.

The cost of this insurance is paid by FIVE BELOW, INC.

Eligibility	
Definition of a Member	You are a member if you are a regular employee of FIVE BELOW, INC., actively working at least 30 hours each week, and a citizen or resident of the United States or Canada. You are not a member if you are a temporary or seasonal employee, a full-time member of the armed forces, a leased employee or an independent contractor.
Class Definition	<b>Class 1:</b> Full Time Owners, Chief Executive Officers, Chief Administrative Officers, Chief Financial Officers, Executive Vice Presidents, Senior Vice Presidents, or Vice Presidents
Eligibility Waiting Period	You are eligible on the date you become a member.

Benefits	
Monthly Benefit	60 percent of the first \$16,667 of monthly predisability earnings, reduced by deductible income (e.g., work earnings, workers' compensation, state disability, etc.)
Maximum Monthly Benefit	\$10,000
Minimum Monthly Benefit	\$100
Benefit Waiting Period	180 days

Benefits <b>Continued</b>	
Definition of Disability	<ul> <li>For the benefit waiting period and to the end of the maximum benefit period that Long Term Disability benefits are payable, you will be considered disabled if, as a result of physical disease, injury, pregnancy or mental disorder:</li> <li>You are unable to perform with reasonable continuity the material duties of your own occupation, and</li> <li>You suffer a loss of at least 20 percent of your predisability earnings when working in your own occupation.</li> <li>You are not considered disabled merely because your right to perform your own occupation is restricted, including a restriction or loss of license.</li> </ul>
Maximum Benefit Period	If you become disabled before age 62, Long Term Disability benefits may continue during disability until age 65, or to the Social Security Normal Retirement Age (SSNRA) or 3 years, 6 months, whichever is longer. If you become disabled at age 62 or older, the benefit duration is determined by the age when disability begins:AgeMaximum Benefit Period623 years, 6 months To SSNRA, or 3 years, 6 months, whichever is longer633 years To SSNRA, or 3 years, whichever is longer642 years, 6 months To SSNRA, or 2 years, 6 months, whichever is longer652 years661 year, 9 months671 year, 9 months681 year, 3 months691 year
